

Holiday Inn Incheon Songdo

Distance to the golf course = approx. 1.3 miles/ 5 min

Modern 4 Star hotel located on the edge of Songdo's Central Park. The hotel is a 20 minute drive from Incheon International Airport, and from the hotel a direct link to Central Park subway station provides easy access to downtown Incheon (3km). Jack Nicklaus Course is 1.3 miles from the Hotel - drive time of approximately 5 minutes.

The hotel has 200 contemporary bedrooms and suites with city views. Rooms are all ensuite with air conditioning and decorated in warm neutral colours and feature a seating area. All rooms have a mini fridge, working desk and free WIFI.
